How do you write a story for Checks and Balances?

I just want to share how I only just realized, at my two-year work anniversary mark, that HP had me come full circle to service in my career. First though I want to talk about some service experience I had in DA.

Years ago at my first WSC*, in SLC* as a brand new GSR*, (lol with the acronyms), I had assumed that I would want to work on the literature committee. I went to their meeting; it was really crowded and seemed to have strong personalities with agendas already in place. It looked boring to listen to them, and that I'd be a silent cog on the wheel for a while. We had been encouraged to go around and check out the various committees for our service, so I went to the Hospitals, Institutions and Prisons (HIP) committee. I think only four or five of us showed up. But we were the cool nerds, in my opinion. We got along great; shared ideas and stories. We got each other interested in helping to reach out to others. We had a fun Board member as our liaison, and we had a lot of energy.

Somehow, during that first year on the Hospitals and Institutions Committee, I got the courage to reach out to the LA County Sheriff Department volunteer office. And after the second or third call, I got someone on the phone who was really interested in learning about DA. He had real enthusiasm! I was invited to the Sheriff's Department's offices at Twin

Towers downtown to present my program, and I had an interview. Then I registered as a volunteer and had to take a class. Shortly after that, I was driving up to Castaic to Pitchess Detention Center to host a panel DA meeting to a weekday class of approximately 100 low security criminals. In the big classroom there were A.A.'s twelve steps and traditions on banners, hanging on the wall. I was very nervous the first few times, but it became a very rewarding and positive routine.

My job as a therapist at a private non-profit was willing for me to donate a few hours a month. Sometimes I carpooled with my speakers; it's not a bad drive and going against traffic from Pasadena. What I learned is that you can't bring your cell phone into the jail, the inmates could be extremely polite, and when they were actually engaged and interested in hearing from you and your speakers, it could be the most rewarding service ever. A DA Story (Continued)

My HIP committee friends and I were able to support each other on some great service experiences, and as a group we got a lot of support from DA. and actually the World Service Office. Our one paid staff person was incredibly enthusiastic about our idea to mail out a copy of Currency of Hope to every Federal prison in the country, along with information about DA, and we did!

I got a bigger, better job that was not keen on letting me volunteer elsewhere for a few hours during work time every month, so I had to let the service go. It was disappointing but the volunteer program was also shifting to a different format that wasn't as comfortable, so it was time. Someone else in the fellowship took it over, and I know others have tried to keep it going, as well.

I never left D.A., and I kept being of service. After three years of being a GSR, I became a Board member. I did one three-year term, and then returned to my home meeting as a 'member among members.' I got married, and five years later divorced, all while in D.A. I have been using my tools and the fellowship to the best of my ability, without debting, one day at a time.

Two years ago, my career took me to where I am now; a supervisor of a case management program for all four of the major Los Angeles Sheriff Department jails. I go back to Pitchess regularly; or did, before the pandemic. I've been in many meetings on that 8th floor in Twin Towers, almost every week until mid-March.

But for the past two years I've wondered; how did I end up here? I never studied forensics, or had a goal of working with the incarcerated. It's tough seeing the system from the inside, in ways that I never would have expected. But it has been very rewarding, and I do see it as both a good career and a way of being of service to my community. But I've asked, why God do you have me here, of all places?

And then the other day, I was wandering around on that 8th floor, looking for the classroom. As usual I was wondering which room was the one I had gone to for that first HIP volunteer interview. I still have no idea; I have not been able to recognize it. And then it hit me: God brought me back to work where I had found such joy as a volunteer.

I'm not doing the same thing at all; I can't even volunteer anymore. But I'm still living the principles of recovery in all areas of my life, and that includes my day-to-day work. I was interested in the HIP committee and loved the volunteer work. I've got a good job now.

Maybe I will see the connection later. But just for today, being of service in this way, and earning a good salary and not debting one day at a time is my way of being on God's path. I don't need to know, or have an opinion, about how it all unfolds. I can trust that I'm in God's hands and being taken care of, in each step,



NEW TO DEBTORS ANONYMOUS?



The governing body of SCDA is the Intergroup. Each meeting is urged to send a representative to the Intergroup meeting, the third Saturday of each month. Without a quorum, the Service Board cannot carry out its functions. Duties on the Service Board are generally not burdensome and we are all aware that we are recovering debtors and try to treat each other with understanding and love.
